Councillor Rains will find out costing's for fencing and report it to the Clerk who will include it into the precept if agreed in consultation with the Recreation Ground Committee.

In relation to the above matter of the Recreation Ground being damaged the Chairman will purchase a Combination Lock and the gates will be locked in the evening and unlocked in the morning in consultation with residents who may be affected.
