16/53.1 Fencing at Stocking Green to discuss whether to put a fence up at Stocking Green.

The residents have put a fence up on the common land at Stocking Green. To put a fence up the residents would need to get permission from the Secretary of State. To carry out any works that would prevent or impede access to common land or for works for the resurfacing of land.

A resident had been dumping soil from his footings for his garage on the Green. The Enforcement Officer had been out, since then the piles of soil had been flattened. Residents have put heaps of soil blocking the farmers access to his field. The Clerk will contact the enforcement officer next week to discuss the fence.
