FOOTPATH 30 RADWINTER

This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the landowner of the land crossed by the public right of way described in paragraph 1 of this Order, it is expedient that the right of way should be diverted.

The landowner, who is the applicant, has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order defray any expenses which are incurred by the processing of the Public Path Diversion Order.

Uttlesford District Council has been consulted and has consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public rights of way known as Footpath 30 over land situated on the property known as Sellands Barn in the parish of Radwinter in the District of Uttlesford and shown by a bold continuous line on the Plan **RAD 30 B** contained in this Order and described in Part 1 of the Schedule to this Order, shall be stopped up after 35 days from the date of confirmation of this Order.
2. At the end of 28 days from the date of confirmation of this Order there shall be a public footpath over the land situated at Sellands Barn in the parish of Radwinter in the District of Uttlesford described in Part 2 of the Schedule and shown by a bold broken line on the Plan **RAD 30 B** contained in this Order.

Route to Close A-B

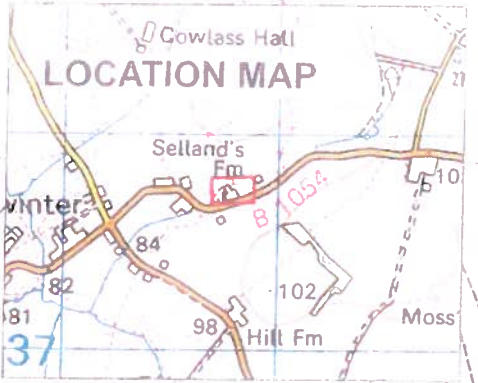
New Route A-C

Unaffected Routes

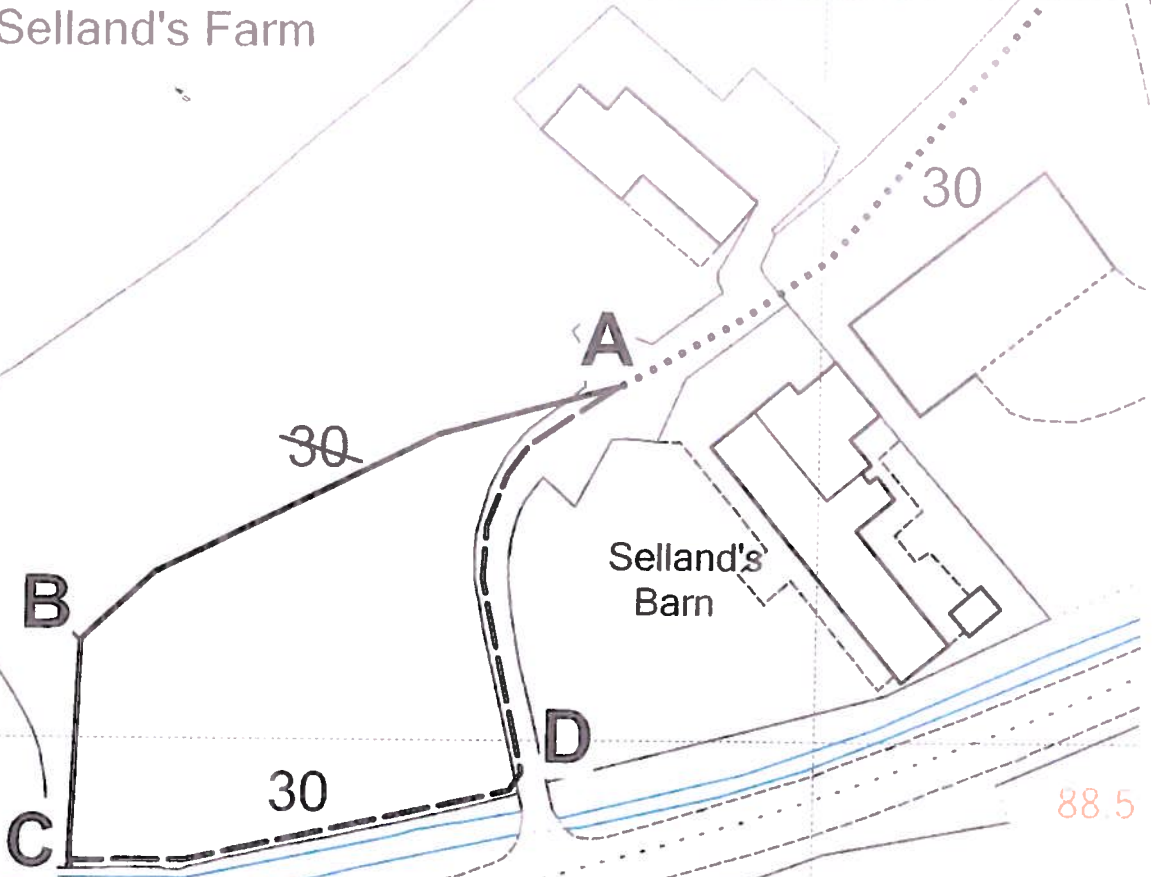

[PART 1]

DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 30 Radwinter of undefined width and shown by a bold black continuous line on the Order Plan, commencing at point **A** at grid reference 56178,23773 and running in a west south westerly direction across the garden belonging to Sellards Barn for a distance of 62 metres to point **B** at grid reference 56172,23771 and then in a southerly direction to the footbridge on the north side of the stream for a distance of 22 metres to point **C** at grid reference 56172,23767 north of the highway, the B1054

DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the Order Map commencing at the aforementioned point **A** and running in a south westerly and then a southerly direction along the access drive for a distance of 46 metres to point **D** at grid reference 56177,23769 then in a generally westerly direction parallel with and on the north side of the stream for a distance of 48 metres to the aforementioned point **C** where it continues unaffected.
