# PUBLIC PATH DIVERSION ORDER HIGHWAYS ACT 1980 ESSEX COUNTY COUNCIL FOOTPATH 50 and BRIDLEWAY 47 RADWINTER

This Order is made by Essex County Council ("the authority") under section 119 of the Highways Act 1980 ("the 1980 Act") because it appears to the authority that in the interests of the landowner of the land crossed by the footpath and bridleway described in paragraph 1 of this Order, it is expedient that the rights of way should be diverted.

The landowner has agreed to defray any compensation which becomes payable in consequence of the coming into force of this order and any expenses which are incurred in bringing the new site of the path into a fit condition for use by the public.

Uttlesford District Council has been consulted and has consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public rights of way known as Footpath 50 and Bridleway 47 over land situated at Lowerhouse Farm in the Parish of Radwinter in the District of Uttlesford and shown by a bold continuous line on the Plan RADW 50 F contained in this Order and described in Part 1 of the Schedule to this Order, shall be stopped up after 35 days from the date of confirmation of this Order.

2. There shall at the end of 28 days from the date of confirmation of this Order be a public footpath and bridleway over the land situated at Radwinter in the District of Uttlesford described in Part 2 of the Schedule and shown by a bold broken line on the Plan RADW 50 F contained in this Order.

#### SCHEDULE

#### [PART 1]

## DESCRIPTION OF SITE OF EXISTING PATH OR WAY

A part length of Footpath 50 Radwinter of undefined width and shown by a bold black continuous line on the Order Plan, commencing at point **B** where it connects to Footpath 46 and running in an east north easterly direction for a distance of 212 metres to point **D** at the farm buildings and then continues in a north north easterly direction through the farm for a distance of 205 metres to point **E** where it connects with Bridleway 47 Radwinter.

A part length of Bridleway 47 of undefined width and shown by a bold black continuous line on the Order Plan, commencing from the aforementioned point **E** and running in a south easterly direction through the fence line for a distance of 100 metres to point **F** where it terminates at the highway known as Water Lane.

### [PART 2]

## DESCRIPTION OF SITE OF NEW PATH OR WAY

A footpath being 2 metres in width shown by a bold broken line on the Order Map commencing at point **G** just north of the field boundary on Footpath 46 and 6 metres north of where Footpaths 46 and 51 connect and running in a generally easterly direction along the north side of the hedge on the field boundary for a distance of 150 metres to point **H** and then continues in a northerly, then a north easterly then a northerly direction around the field boundary for a distance of 84 metres to point **J** where it connects o Bridleway 47 but 70 metres further to the north west than the current path.

A bridleway being 3 metres in width, shown by a bold black broken line on the Order Map commencing from the aforementioned point **E** and running in a south easterly direction along the existing track for a distance of 58 metres to point **K** then continuing in a south easterly direction along the track for a distance of 46 metres to the aforementioned point **F**.
