- Energy Switch closes 10/2/2020
- Partner 100K cycle route, from Hyland Park is likely to come through the village. There will be a rolling road block, possible dates are 3rd and 20th September 2020
- The Council is proposing to allocate £5 million to new road repairs
- Climate change is being taken very seriously with a new group which is being chaired by a Chairman from the House of Lords. Two young people from Essex will sit as Vice-Chairs. They will bring in experts to look at how the county council can reduce their carbon footprint, plus what steps the wider county can take.
- There is a Forest Initiative to plant 375,000 trees. The PC can tap into this.
- The CC has spoken to highways about the gravel store at Stocking Green, and the need to close the bund. A Highway officer will visit.
- CC noted the flooding as you come into the village.

20/10 Recent Planning Applications:

UTT/20/0027/DFO Potash Farm Details following outline approval UTT/19/2457/OP for the erection of 2 no. semi-detached dwellings - details of access, scale, appearance, layout and landscape scale appearance and layout, ClIrs felt they couldn't comment on the plans for the houses due to an error on the plans.

UTT/19/3104/FUL Land At 2 Mill End Cottages Erection of 1 no. detached dwelling with associated landscaping works and new vehicular access

The Parish Council are concerned about the development at Mill End Cottages for the following reasons:

- The Parish Council continue to believe that 'ribbon development' on agricultural land outside the village envelope should be resisted. The location of 'Plough Ridge' is outside the village envelope, on agricultural land (per Land Registry records).
- 2. The proposed access to the highway on the Ashdon Road is of concern, since fast traffic coming from Ashdon, and traffic turning off the B1053 towards Ashdon, together with the narrowness of Ashdon Road at this point, have potential to make the area dangerous, especially considering the nearness of the Plough Inn (which makes the junction very busy).
- 3. The development is proposed for an exposed site. The modern design, whilst using local materials, is a significant contrast to the surrounding housing (specifically The Plough Inn, and the Old Chapel House).

20/12.1 To discuss the email from Dr Albert Gerhard

It was agreed that the Clerk notify Highways of the issues and the need to enforce Section 34 of the Road Traffic Act 1988 that makes it a criminal offence to drive over, or park on land (including greenland) not forming part of a road without lawful authority to do so.

Cllr Davidson will draft some words to put a sign asking people not to park on the grass at Stocking Green.

All other issues are not enforceable by the Parish Council, who noted that there is a bridleway diagonally across the field.

Clerk to find out who owns the land at Stocking Green – this may be the PC.

20/13 Reports from Councillors with matters affecting the village

The Speed Watch Group has been told the road outside the stable is too dangerous for doing speed watch. Councillors expressed concern about this, since if the road is too dangerous to monitor traffic speeds, it is also too dangerous to walk on. This is a major concern, given the proximity of the Livery Stables, and public footpaths and bridleways at the corner. Council to discuss further.

20/14 Neighbourhood Plan Update

Cllr Richardson and Gareth Wilson have put together a new survey, which they are hoping to put out with the Ambo. Gareth is putting together a broad timeline for the Neighbourhood Plan. They are hoping that the next Steering Group meeting will take place in March.

The Council agreed that there is a lot of information is duplicated. The Council agreed that the Welcome Letter should be put on the Website. Cllr Richardson to send it to Cllr Fitch to put on the website.
