The DC noted that the Local Plan had been withdrawn. Cllr Richardson asked how long the new plan would take to produce. The DC said it was usually five years, but that they are hoping to use some of the information they already have so it may be shorter. They must produce a Local Development Scheme first

20/70 Recreation Ground Update

The Clerk and Cllr Richardson have had numerous emails and telephone conversations about the entrance to the recreation ground, after people tried to break into the car park on 2 separate occasions. The 2nd night the people were very abusive to a resident - the incident has been reported to the Police, who have interviewed several residents and taken statements.

Cllr Richardson, Cllr Fitch and Cllr Duck managed to put some harass panels to close the entrance off and the Chairman of the Cricket Club has put the large grass roller

behind the panels to stop anyone getting in. This is suitable in the short term, but clearly not a long term solution.

The Clerk and Cllr Richardson are in the process of getting quotes to widen the original gates so they can go back up. Cllr Rains will look at getting a price for some agricultural gates in case these prove to be a cheaper alternative.

The Recreation Ground committee (RRGC) have opened the Muga, Tennis Courts and the Bike track - they are not attempting to police the use of them but its open. Anyone using the facilities must follow the latest government guidelines. The RRGC, will be monitoring via CCTV and anyone not following guidelines will be reported to the Police.

The entrance at the far end has been blocked off by farm machinery.

20/70.1 Potholes in the Car Park.

The Potholes have been repaired while the Recreation ground was closed. The Recreation Committee have said that they would prefer that the car park remain closed until September. Whilst this makes sense in the light of the recent damage, the whole question of the respective remits of the PC and RRGC with regard to access is not at all clear from the lease. Cllr Richardson agreed to look into this and produce a paper for the Council.
