The Council is supportive of additional retail facilities in Radwinter but was concerned the single entrance and exit to this proposed facility may pose a safety hazard. Traffic on the road (the B1053) travels at speed, and since the entrance is only wide enough for one vehicle to either exit or enter the yard at a time, there is potential for cars to be stationery on the main road, waiting to enter. The Parish Council feels this could be extremely dangerous.

The Council suggests that the application be amended to rectify this problem, or if this cannot be done, be refused on safety grounds.
