20/206 Recreation Ground Update

Cllr Richardson and Cllr Duck both attended the Radwinter Recreation Ground Charity (RRGC) AGM.

The RRGC Committee has lost some of the committee members but have gain a couple of people; Julie Haines is looking at stepping down as Chair at the next AGM.

Financially, there is a reduction in income due to Covid 19 - prior to the pandemic, they were bringing in about a £1,000 a month in income, which was about breakeven before putting money aside for future maintenance and repairs. The RRGC expect to lose money this year due to Covid 19.

At the end of March 2020 (ie before Covid-19) the Rec Committee had £32,000 in the bank account, £16,000 unrestricted (although intended for work on the bike track, MUGA and Pavilion), £3000 restricted for work on the bike track, and £12,0000 'own funds". Since the year end, a grant of £7,620 was received to assist with additional running costs during the Covid Pandemic. In view of this there are no immediate financial problems, although the situation for the future is less certain.

The Council agreed they will remain available to help out if needed. Cllr Duck suggested it would be a good idea to have a donation box at the recreation ground for people who come from out of the village to use the Bike Track.

20/209.2 Flooding

The Clerk has reported numerous flooding issues, The Clerk will see if ECC can rod the Hall Farm Flooding as this one is extremely dangerous when flooded.

The road junction from Radwinter End onto the Ashdon Road was also experiencing flooding. Ditches on Water Lane were overflowing, and repairs to Water Lane have not taken place as a result.

The Clerk suggests that if residents take photos of the flooding and pass them on to the Clerk she will log it with ECC Highways

20/210 Stocking Green update Cllr Davidson to Report

Cllr Davidson reported that James Briggs had died.

Residents have put a notice up asking people not to park on the grass. Three residents are looking to redirect footpath PROW 43-53, but the farmer wants a considerable amount of money to do this so there is a good chance that this wont be done.

We have received a request from Essex County to register the Bus Shelter next to the Church, and to potentially replace it with a metropolitan style shelter and an advertising hoarding. The Council were unanimous in rejecting this idea. The Clerk was asked to ascertain who owns the land on which the shelter is situated (the Council itself owns the structure) and to find out the basis for the request to licence.

The Clerk has looked at the Wimbish Website which was done by a lady in the village, and will seek a quote from her and the other company that has been identified. Cllrs wanted the entire website revamping, not just the PC element. It was thought that the new site could hotlink to existing webpages such as the Village Hall and the Recreation Ground.

20/215 Electric Car Rapid Charing Point

Cllr Williams has investigated costs and obtained some information. There are grants available, although the council would need to put in 25% of the cost. The Clerk and Cllr Williams were asked to get more information - the Clerk to speak to Saffron Walden Town Council to see who is responsible for the ones in the Common Car Park, and possibly ask EALC for information and help.
