20/185.1 Refurbishment of the old toilet block and tree work Cllr Richardson had a meeting with the Rec Committee, they are not

running out of money at the moment, they are more concerned about in the future as we don't know how things will go due to Covid 19. They have decided not to refurbish the old toilet block at the present time, they will look at disability grants and see if that's feasible.

Costs have been reduced apart from normal electricity and on-going maintenance of the playing field and hedges. Cllr Richardson said that we will help out later in the year if needs be. They are reliant on the £3,000 for grass cutting which will go up to £3,500 in 2021/22.

The Men's shed asked permission to put a new roof on the shed and patio out front. This was **agreed** by all members of the council

The Clerk suggested that Npower should come and fix it saying it a dangerous situation and play on the fact that people using the car park. To look at preparing the budget for 2021/22 The Council looked at the budget form, and discussed various options. The Clerk is now waiting for the base tax figure from UDC before anything can be finalised.

20/187 Recent Planning Applications:

UTT/20/3000/FUL Proposed erection of 2 no. Dwellings. Applecroft Roman Road The Council noted that this development was outside the village envelope, and that it contributed to further 'ribbon development' along Roman Road (since the development of new properties next door in Wimbish Parish UTT/13/2678/FUL). The Council also noted the recent refusal of planning permission for two houses at 'The Meads' close by (Appeal Ref: APP/C1570/W/20/3247084) partially on the grounds of conflict with Uttlesford Local Plan Policy S7.

However, the Council noted that the design appeared more in keeping with the 'Essex Design Guide' than the neighbouring developments, and that the boundary hedges and ditches were to be retained – an important factor.

On balance the Council decided, notwithstanding the issues in this particular case, that due to the location next to the UTT/13/2678/FUL development, they would not object to this application.
