21/83 Land at the Rear of Gillon Way

The Clerk has sent a letter to Enterprise (the developer) regarding the open space at Gillon Way. Cllr Richardson has found out that residents of Gillon Way pay a service charge to the developer to cut the grass and take care of their street lights. The Council will need to look at the land transfer agreement very closely when we get it, and see if residents still have to pay a service charge. The residents are concerned as the grass had not been cut even despite the charge. Cllrs noted that if the Council take on the piece of land, it will be important to ask the residents what they would like to be done with the open space.

21/84 Electric Car Charging Point

Cllr Williams informed the council at the present time ECC current policy on Electric Car Charging Points is for on 'street charging points' only and we wouldn't fit into this policy. There will possibly be a new scheme in the New Year and Cllr Williams has asked to be kept informed. The Clerk to pass on email addresses for neighbouring parish councils to Cllr Williams to see if they are looking into charging points in their parishes – the Council thought the more smaller councils that get together, the greater chance that the County Council may put a smaller communities scheme in place.

Cllr Richardson and The Clerk had received two applications for the new Clerks position. A discussion took place with both applicants and Mr Luke Brown is the preferred candidate. Cllr Richardson proposed a 6 month initial contract (to be extended after a satisfactory review), pay scale to be SCP 12. Cllrs proposed an increase once Cilca qualifications have been achieved. Cllr Richardson to communicate terms to Mr Brown, take references and finalise the contract if satisfactory.
