21/275 Apologies for Absence

21/276 Public Forum

The member of the public went through with the Council the details of the lighting project to light the track from the Rec car park to the pavilion, which the Council has taken over responsibility for. There are to be 4 Solar powered lights installed that are triggered on via sensors and turnoff after a delay. The installation will be permitted development and will not require planning permission. The Council, prior to the install, will provide the nearby properties the plans as a courtesy.

DC Smith report – UDC are recruiting a new director of planning and the preferred candidate has accepted the position.

There has been a spate of drainage cover thefts- please be aware and report any sightings to the police.

The Government is providing £150 to help with the increasing energy prices.

The Chairman noted to the Council and DC Smith that the advert for the new postmaster for the post office in the village was taken down almost immediately. As a result of a complaint, the advert has gone up again but now states it as a franchise (and that the franchisee needs to provide premises). There has been someone locally show interest but was turned down due to living too far away, which doesn't seem right as the previous postmaster lived further away. Chairman to write to ClIr Smith, who will pass the letter on to Kemi Badenoch MP to hopefully help - it feels like the post office are looking to close the service down completely in Radwinter.

21/280 <u>Clerks Report</u> (APPENDIX A)

The illuminating speed sign at the East end of the village, which Essex Highways are refusing responsibility for, was probably installed over 15 years ago and therefore the Council think it must be Essex Highways that installed it. Clerk to contact them.

The Council think NALC's response for the Ukrainian crisis is poor and will look to help Saffron Walden as it is expected that it will be the centre for accepting families in the area. The Chairman will write a response to UDC regarding the situation.
