DC Smith gave his report to the council. The District Council (DC) are required to have a 4–5-year land supply for building developments, currently they have a little <5-year supply. The DC is giving £300,000 to the leisure centres it is responsible for, the money is to help with the rise of energy costs over the winter.

ECC Foley gave their report to the council, highlighting the deficit of mental healthcare available for schools.

Cllrs asked about 20MPH speed limits, ECC Foley noted that there are specific criteria that need to be met and a form needs to be submitted, the sooner the better. – Clerk to investigate.

Cllrs asked about the salt bins in the village and about installing new bins. Essex Highways no longer refill salt bins or install new bins, that is now the responsibility of the parish council, but ECC Foley has a locality fund that he could use to help fund a new salt bin. – Clerk to investigate. The council aimed to set a date for a meeting with ECC Foley to go through highways issues, date set for early February.
