APPENDIX A District Cllr Report

1. Essex Electric Vehicle Charge Point Strategy

Currently 300 registered public charge points in Essex, but 1,500 predicted needed by 2025, and 6000 by2030. The strategy sets out how to deliver the "Right Charger in the Right Place". 2. For information the appeal against the decision by UDC to reject the application to build 18 houses at Sparepenny Lane Great Sampford was lost at inspection.

The most important reasons for this were:

Harm to the rural setting of the village.

• The proposed development would not be sustainable given the lack of services, poor transport links (rural roads, lack of bus routes, distance from railway stations, lack of bicycle routes etc etc). This is clearly important given similarities to Radwinter.
