# Radwinter Parish Council Minutes of the Meeting 17th January 2011 Held in the Village Hall at 7.45pm.

### 1. Apologies and reasons for absence:

## 2. (out of order) Report from C/CIIr:

C/Cllr Simon Walsh reported on the continued cost saving activities of the Council. The Careers Advisory Service is closing. This was received with concern since there is no Job Centre in Saffron Walden; Cllr Duck suggested that an Outreach Programme from Braintree to the schools is required. The school transport programme is also being reviewed in conjunction with the Local Transport Plan, on which comments are requested. Highways have also been restructured with the loss of 100 staff but are maintaining their services. There is road salt available, and pot holes will receive attention. The Fire Service is not losing any facilities, in fact Dunmow is being upgraded. The Police Service are reducing their Community Speed Watch facility and some reduction in Neighbourhood Watch back-up.

### 3. Minutes of previous meeting of 29 November:

Having been previously circulated they were taken as read and signed by the Chairman. (He later stressed the need for all Councillors to carefully read the draft)

### 4. Matters arising not otherwise covered:

The new format of the minutes was discussed and it was agreed that the increased information provided was beneficial. The Action Sheet is to be added for general distribution. The budget figures are to be deleted.

#### (C) Other financial matters:

The tenants of Walden Road Cottage have given notice wef 24 February. FDPM already have new tenants.

A press release from DEFRA has stated that funds are available for flood relief measures under Flood and Water Management Act 2010.

An application for support has been rec'd from CAB Saffron Walden. It was agreed that in view of help to residents a donation of £50 should be made.

A burst pipe in Walden Road Cottage has been repaired at a cost of £183.50

### 6. Review of Action Schedule: see attached

Cllr Moore raised the matter of the change in the location of the speed limit signs in Water Lane and why it was not on the Action Sheet. He was informed that it was on the Action Sheet as the first item on the deferred list, in conjunction with a similar change in Wimbish Green Lane. The matter has been raised with Hways on more than one ocassion and we have been repeatedly told that funds are not available due to the legal costs. We can ask them to reconsider the matter for the coming year.

Hways have informed us that B1053 Walden Rd will be closed between Tesco and Sewards End for 5 weeks for drain laying wef 17 Jan.

Flooding in Walden Rd by Hall Farm has been inspected and the pipes blown.

Pot-holes at Bridgefoot and by Frog's Croft have been reported.

A request has been made for an allocated disabled parking space in the car-park; Cllr Jarvis to action.

### 7. Other items for review:

#### (A) Hall notice board:

the refurbishment has now been completed; there was increased expenditure as a result of upgrading.

#### (B) Stocking Green:

A letter has been received from James Briggs regarding the water main for various Stocking Green residents. It was agreed that the Council has no liability but that the residents should be given moral support, without prejudice.

A meeting is to be arranged with Mark Iley of Essex Biodiversity regarding improvements to Stocking Green.

#### (C) Recycling facility:

Another complaint has been made by residents to UDC regarding the condition of this facility; we have also received one regarding the intrusive noise to Almshouse residents.

#### (D) Almshouse frontage:

A request has been received for the removal of the hedge in front of one Almshouse. The matter is to be discussed further with the other residents and Almshouse Trustees; Cllr Halls to action.

#### (E) Broadband:

The BT 'race to infinity' scheme has now closed, but will continue with Hempstead PC to lobby BT for a better provision.
