Public Session:

(a) Cllr Howell introduced himself to the Council and promised his co-operation. He noted various points including glass recycling.

Confirmation of our continued financial support was given. Interest in early development of the pavilion was agreed and a meeting arranged on site for Monday 6 June. He would ensure that minutes and accounts would be regularly forwarded.

It was noted that Cllr Shoolheifer has already been appointed as Council nomination to the Charity for ths current year, in addition to the Chairman ex officio.

10 Finance:

(A) Statement: Funds at 18 May: £45,459.58

(Bi) Report of the Finance Committee Mtg 10/12 May:

The minutes were circulated and the points for action noted. The recommendation for a contribution of £3000 this year to the rec committee was accepted.

(Bii) Report of the Staff Committee Mtg 3 May:

The minutes had been previously circulated and the recommendations accepted, including the appointment of messrs Douglas Tonks as agent for HMRC, and the revised pay structure for the Clerk/RFO. He would retain his grading but the weekly hours of duty cut to 6, eliminating the former supplementary fee of May 2010. He would in future be paid bi-monthly.

(C) Approval of the annual accounts and report:

These were inspected and a report made by the RFO. They were approved and signed by the chairman, together with a report to the external examiner. The Financial Advisor was thanked for his continued help. He has already agreed to serve as before, having noted the requirements of the Accounts and Audit (England) Regulations 2011

(D) Current expenditure and signing of cheques:

receipts: UDC £40050 (half precept); interest £7.28.

Payments: R A Jones £ 70.20 (154 - expenses); Cllr V Boyden £175.61; BT £59.80 (d/d PO phone). Retrospective consent for payment of R A Jones £467.00 (153 - May fee part reduction) Payment of all items was approved and cheques signed later.

The RFO reported that the Finance Committee had revised the valuations for assets following the discontinuance of the village hall and outbuilding insurance and the subequent incorporation on to 1 policy. If the recommendations are adopted in full

the cost would rise from £1033.14 to £1462. he was instructed to examine the requirements in more detail and obtain other quotations.

(E) Other financial items:

The Clerk reported that the Council copy of 'Local Council Administration' by Arnold Baker had been lost by the previous Chairman, and it was important that the present Chairman had one. The cost is £62.50 from EALC. The clerk was instructed to purchase one to be kept in the VH muniments room.

SSE have requested renewal of our subscription £10. It was agreed that this should continue to be paid.
