If working with CHB to install a community defibrillator, as much electricity as is required by the AED cabinet can be used free of charge. In addition, should the community wish it, an emergency telephone can be reinstalled by Community Heartbeat and they are waiting on final pricing before we are able to provide an accurate monthly rental figure.
