15/115 Members of the public are welcome to attend the Parish Council meeting. Those wishing to speak or raise any issue are requested to do so at.

Julie Haines came and spoke about the recreation ground; the lease has been registered with the Land Registry.

The new piece of land in which the new football pitch and MUGA will go on will need the parish council to apply for change of use. This can't happen until after 6 months after the implementation date. Uttlesford District Council will notify Sir Jonathan Parker if the Parish Council wishes to take on the recreation land and for this to be legally transferred to Radwinter Parish Council. The implementation date is a date when the developer advises UDC when the development is to start.

On the premise that the Parish Council want to take on the recreation ground, then within two months of written notice from UDC the transfer will take effect. In effect the Parish Council need to write to UDC within 6 months after the development has been implemented advising that the Parish Council want to take on the recreation land. If the Parish Council does not, the land will stay within the ownership of Sir Jonathan Parker.
