The DC suggested that Parishes could club together to match fund a PCSO for a year with UTT, the parishes would need to pay £20,000 per annum this would be spread across the parishes and this would need to be a commitment for at least 2 years. Cllrs felt villagers needed to be more vigilant and take note of suspicious vehicles and people.

The DC mention that the Parish Council hadn't put any Asset of Community Value in to UTT Councillors will consider this.
