APPENDIX A

District Councillor's Report

Council's Medium Term Financial Strategy

Since the financial crash in 2008 Local Authorities have been reviewing how the fund the statutory services they are required to provide. Traditionally Councils received a share of Council Tax (which is insufficient) and additional funding from Central Government. One such government scheme was the New Homes Bonus whereby Government rewarding Councils with money if they were helping towards the National house building policy. Over the past 10 years or so, this central funding has been starting to reduce and the trend is expected to continue, creating an apparent shortfall in future budgets. Uttlesford like some other Councils identified that they could fill this gap by borrowing money from the government at low rates of interest, in order to invest in assets that could fill the potential funding gap.

The previous administration purchased a 50% share in the Chesterford Research Park through an umbrella Company, Aspire. Further money has gone into CRP but ultimately this has proven to be a strong investment, not just because it is in our own district but because of the contribution it is making to the Council's Budget. The R4U have adopted this investment policy and gone further. The Council has borrowed £300 million and have purchased a total 6 commercial properties. All of our investments together yield an income to the council of about £7.1 million and this is budgeted to grow to £12 million by 2026. You may be aware that some local authorities have been in the national press recently (Croydon, Slough, Spelthorne & Bristol) where they have made risky and/or unwise investments which haven't paid off. Other Councils have significant shareholdings in Airports (Manchester, Luton) which have suffered heavily through Covid. The Government are concerned about the ease in which Councils are able to borrow (sometimes recklessly), go bust and then go to the government for a bailout. As such there is a consultation led by the Chartered institute of Public Finance and Accountancy to propose changes to the way Councils are able to invest. This is only a consultation so the precise changes that might occur are unknown. However, the Council might have to sell off all of its investments which would then put the Council back to the drawing board on how to fund its services.

This is far in excess of the amount that was required to fill the expected budget deficit in the future, and if the Government decide that Councils can only borrow to fund statutory services we will have to sell of some of these assets.

News from the Council Chamber

Cllr Foley is back following his wife's illness.

Cllr Lodge has announced that he is to step down as Cllr Leader at the December mtg, his successor is yet to be announced but expected to be Cllr Lees, the current Deputy.
