CCIIr Foley highlighted their meeting with a member of the council to go over highway issues in Radwinter and noted that with the upcoming bicycle event the road surfaces along their route are being repaired, which should benefit Radwinter.

CCIIr Foley requested that the Clerk write to them asking for speed monitoring next to the VAS sign so that Radwinter are added to the queue.

The Cllrs questioned the report on the road calming at the West end of the village, which seems to be the wrong way round and dangerous to road users.

DCIIr Smith gave their report on the issue the Parish Council are having with the developers of Gillion Way, who are seemingly unnecessarily delaying the handover of the land due to the Parish Council as per the agreement. DCIIr Smith noted that enforcement is keeping an eye on the situation but are not going to intervene at this time as they believe it should be resolved within the next few months.

The Chairman gave evidence that it seems to be a ploy of the developers to keep promising that they are going to complete the transfer soon and instead delay further. The Chairman agreed to forward correspondence to DCllr Smith to send to enforcement.

The Clerk gave their report highlighting the overpayment to A&J had been refunded. The Parish Council noted they were unhappy with the contractor's ability to withdraw funds from the Council's account at will.

# RADWINTER -ECC CLLR MARTIN FOLEY REPORT YEAR -APRIL 2023

#### New Booking System at Recycling Centres (ECC)

As you know I think the new system is a sledgehammer to crack a small nut and they would have done well to speak to Parish Councillors/District Councillors and gone out to proper consultation first. I am strongly opposing it, as in the trial that has already been done recycling has actually gone down amongst other problems.!

#### Youth/Youth Club Support

Over the past year I have secured funding for Youth Clubs including Sampford ...it came from the locality fund. I have spoken to Martin Boutwood to think of a bid for 2023/4 Locality Fund

#### Libraries

You may recall Dr Mike Tayler and myself amongst other things headed a campaign to keep Libraries open. Well we succeeded with the help of a number of people who came and lobbied at County Hall with us. We need to keep Libraries open by using them...so please if you haven't got a library card go in and get one and use it or we may be faced with closure again one day. ECC are not in a great financial situation and the current administration in County Hall have shown they don't have much time for public libraries. I am concerned they may try and close it again when you look at the state of ECC finances.

#### **School Assemblies**

I have done a number of school assemblies in the area including Thaxted with Dr Tayler and with John Starr from my Youth Strategy Group, I am planning to visit this local primary school soon. I am delighted to see so many well run school despite funding issues from Central Government and teacher unrest with conditions.

Mental Health Practitioners in Senior Schools – Through a motion I took through County Hall last year we have secured funding for help in this area for secondary schools in Saffron Walden and Dunmow.(Final Report Mental on Mental Health attached)

#### **Highways**

I visited Radwinter with Sarah Tomlin I have taken up dozens of issues in the last year including potholes, drainage and other major issues. One really annoying thing is how quickly fixed potholes deteriorate ... often doing things on the cheap is not the cheapest in the long run. ECC needs to "Take Control" of the work and check work done by contractors are up to scratch ..I am making a point in spelling this out to the appropriate people.

Shortage of staff in Highways Department and helping out at Thurrock (another failed and deeply in debt Tory council being looked after by ECC) seems to be adding to the problem according to some staff at ECC.

The closure of the bridge on B184 brought with it many problems and we were all glad to see it finished. Please report any issues through ECC website.

# **ECC - BUDGET 2023/2024**

At a lengthy meeting of County Council in March 2023, the 2023/24 ECC Budget was set and an increase of the UDC share of Council Tax precept of 3% was approved in order to arrive at a balanced budget. EEC share was 3.5%

A real achievement at Essex and even more for UDC given the huge cuts in central government support with other conservative councils begging to increase further like Croydon, Kent , Surrey and of course Thurrock asking for almost 10% increase.

#### **Local Plans**

Local Plans are very much on peoples lips in Essex as well as UDC .We have at UDC <u>been waiting 15 years on a plan that will not fail</u> (all plans failed under last administration – costing tens of millions pounds now) so it needs to be right this time. Flaws were found in previous evidence submitted but should go to next step still by year end.

There are at least 20 plus other local councils like this and some seem to be treading water waiting on numbers to come down.

#### **REGISTERING TO VOTE – MAY 2023**

An extensive campaign has been taking place, prepared by the Electoral Services Team at UDC, to advise the community of the new Voter ID requirements coming into effect at this Election for the first time. It will be necessary for voters exercising their vote in person to show some form of photo ID at the voting Station.

This further link provides information as to the accepted forms of photo identification and if voters do not already have an accepted form of photo ID, or if they are not sure whether their photo ID still looks like them, they can apply for a free voter ID document know as a Voter Authority Certificate (VAC). We urge residents to check that they have appropriate photo ID and of course take it with them when they attend the Polling Station on the day. Many will have a suitable ID tucked away n their wallet or purse already and it is perhaps just worth listing examples of what are appropriate photo ID documents, namely:

- Passport issued by the UK, any Channel Islands, the Isle of Man, A British Overseas Territory, an EEA state or a Commonwealth country
- Driving licence issued by the UK, any Channel Islands, the Isle of Man or an EEA state
- Blue Badge
- Older Person's Bus Pass
- Disabled Person's Bus Pass
- Oyster 60+ Card
- Voter Authority Certificate (VAC) or a temporary VAC
- Biometric immigration document
- Identity card bearing Proof of Age Standards Scheme hologram (a PASS card)
- National Identity Card issued by an EEA state

And Finally I would like to warmly thank Thaxted PC for their work in looking after Thaxted together with Richard Haynes who has both advised the PC and Cllr Tayler and myself in the past year.

There has also been Brilliant work done by HOT and The Thaxted Society, Friends of Thaxted Church, The Thaxted Youth Club and man more organisations on our behalf and it is much appreciated.
