Local Highways Panel Update

Going over with Sarah Tomlin request for upgrading speed limit area requested.

I am petitioning ECC about the dangerous state of Rural Roads in this part of Essex at next Full Essex County Council Meeting this month. I have already had support from every PC I have gone to this spring, and I ask Radwinter PC for theirs now.

Busses

Bus numbers 301 316 318 319 320 321 where at risk when the contract was in dispute between ECC and the bus company. Some services have been returned but before 9am services are not running yet on all services.

Cllr Martin Foley

My first was a question to the District Council on 23/4/2024.

I note that County Councillor Foley has not had a response from the Leader and CEO of Essex County Council to his request for an urgent enquiry into the withdrawal of bus services of in Uttlesford on 14th April. Although we are grateful that, through the efforts of Councillor Foley and others, a temporary solution has been reached, we note that Vectare, the bus provider had provided a due, and appropriate warning to ECC on 12 February, that they were unable to operate bus services due to apparently unachievable timetables. There then appears to have been a failure of communication resulting in services being withdrawn inspire of this warning. A clear understanding into what has gone wrong is needed so that a permanent solution can be found between ECC and the providers. Could our Leader and The CEO please support Cllr Foley's request for such an enquiry?

The basis for this question is to encourage ECC to improve rural bus services over a longer term to help with the sustainability of our community.

The second is more nuanced.

As the Chairman of the Trustees of Pam's Place, previously run as The Day Centre in Thaxted, I raised, at the Annual Meeting last week my wish that we should reach out into the Local Community to encourage people of all ages, but particularly the socially isolated to come for meals and community activities offered by this centre.

The building of Pam's Place is owned by UDC, but it as run as "a Charitable Incorporated Organisation set up to benefit all the residents of Thaxted and the surrounding area." To find out more visit www.pamsplace.org.uk
