Appendix A

Gillon Way Section 106 agreement

I have received a somewhat confusing email from the UDC legal department which I think follows an email I wrote requesting clarification of the Section 106 agreement. I hope we can have a brief discussion about this this evening so I can, if appropriate reply.

Local Government Reorganisation.

On 23rd October the Council voted overwhelmingly for "Business Case A" for Essex wide local government reorganisation, as opposed to three other business cases. An amendment was proposed that we should support "Business Case B" but this was defeated.

This means that UDC is writing to the Government supporting the merger of Uttlesford, Harlow and Epping, to become one of five unitary authorities in Essex. Business Case B proposed Uttlesford merging with Braintree Colchester and Tendering which would mean a much larger unitary authority, one of three in Essex. A majority of district councils support the five unitary authority model, whereas Essex County Council appear to be supporting three. The final proposals have to be submitted to the Government by 26th September.

The final decision is being made by the Government.

Elections for the Mayor of Greater Essex on the 7th May 2026.

The new unitary authorities are due to commence in May 2028

The Local Plan

On 24th October the Local Plan Panel met. This was largely to agree major modification to the Local Plan which have been proposed to rectify some concerns that the Inspector made during the examination between the 9th and 19th June. This is to ensure that the Plan is sound and legally compliant. There was no option to alter these modifications, but the Panel agreed the changes.

There is now a public consultation on these main modifications which runs from 15th September to the 27th October. This consultation can be reached via the Local Plan Pages on the UDC website.

As far as Radwinter and the Sampfords Ward are concerned there appear to be no direct Main Modifications, largely because there were no Strategic Sites proposed. I was surprised that there had been no comment about Core Policy 25 which concerns Renewable Energy Infrastructure, but I was told that this is because there is going to be a piece of work done by the Council to underpin this policy.

Lastly one other interesting piece of news is as follows:

UDC is pleased to share the news that Essex has stopped sending general waste, including Uttlesford's, to landfill. Instead, all non-recyclable rubbish is being sent to the Energy from Waste facility in Rivenhall, where it is converted into electricity for the national grid.

So far, over 10,000 tonnes of waste has been processed. This is a major step forward environmentally, although the facility can be a sensitive topic.
