This Order is made by Essex County Council (“the authority”) under section 118 of the Highways Act 1980 (“the 1980 Act”) because it appears to the authority that it is expedient that Footpath 51 Radwinter should be extinguished on the grounds that it is not needed for public use

Uttlesford District Council has been consulted and has consented to the making of the Order as required by section 120(2) of the 1980 Act.

BY THIS ORDER:

1. The public right of way known as Footpath 51 situate at Lowerhouse Farm in the parish of Radwinter in the District of Uttlesford and shown by a bold continuous line on the Plan RAD 51 X contained in this Order and described in the Schedule to this Order, shall be stopped up after 28 days from the date of confirmation of this Order.

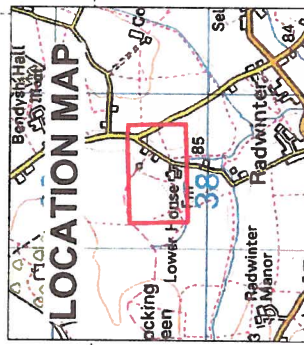
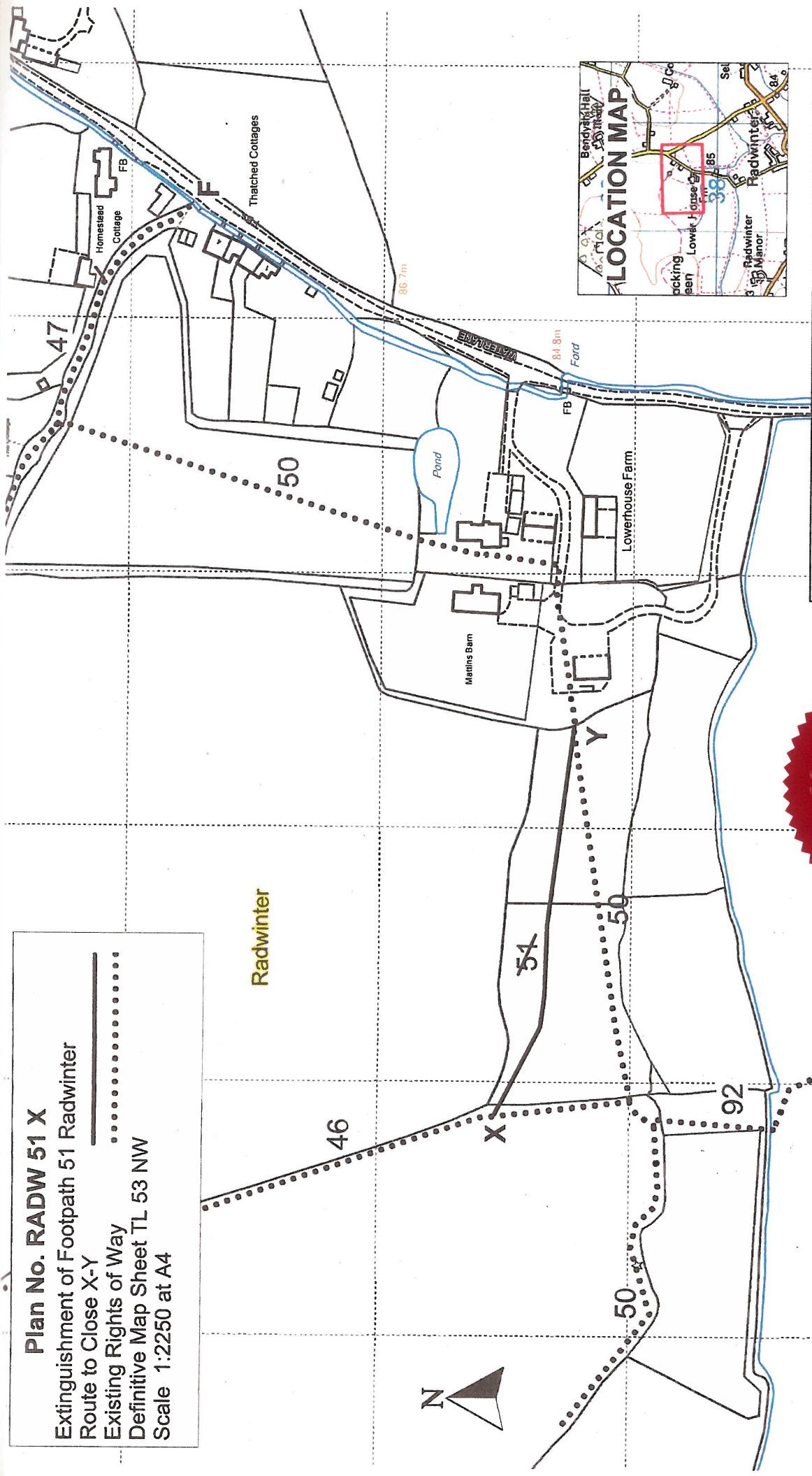
